Consumption and use

Recommended dosage:

For soft serve: Add 1kg powder to 2.25 litres water (max 2.5 litres) For milkshakes: Add 1kg powder to 3.5 litres water (max 4 litres)

Preparation directions:

Gradually whisk the soft serve mix into the water until powder is completely dissolved. Leave it to stand for

at least 20 minutes for hydration and aging time. Then whisk again briefly but vigorously.

The mixture should be pre-chilled at a temperature of $\leq 10^{\circ}$ C before using the ice making machine.

Packing and storage	Keep the product in its closed package, away from the sunlight, in a dry place ($RH < 75$ %), at a temperature under or equal 23 C°. The product is in Multiply Kraft 25 kg net paper bag and Big bag with a polyethylene liner.
Shelf life	Maximum 12 months from the production date, respecting the outlined packaging and storage terms.
